
### **CSG EXCHANGE OVERVIEW**

CSG Exchange is a core component of CSG Wholesale Business Management Solution (WBMS). The service automates and formalizes the management and processing of updated contractual information that an operator receives from its partners.

- Secure upload of data from a private, webbased email account drop box
- Notification and alerts to both parties as information is processed
- Formalized acceptance or rejection of transferred information
- An official repository of approved documentation
- Automatic loading of relevant data into billing and routing systems
- Compliance with GBET templates and protocols

### THE SERVICES OF CSG EXCHANGE

The Refile Agreement service automates the receipt and processing of refile rate sheets with partners. Rate sheets can be received and parsed in multiple formats, including sheets for Refile, Hubbing, Direct In/Out, and Transit In/Out. The service validates the incoming rate sheet and provides acceptance or rejection notifications to the supplier on a line-by-line basis. The approved information is centrally stored and uploaded into the inter-carrier billing and routing system.

The Bilateral Agreement service automates the receipt and processing of bilateral agreement annex sheets with partners. These sheets will be received in specific formats compliant with GBET standards. The service validates the incoming sheets and provides acceptance or rejection notifications to the bilateral partners. The Bilateral Agreement service supports storage of the approved sheets as well as data upload into the inter-carrier billing and routing system.





THE BILATERAL AGREEMENT SERVICE AUTOMATES THE RECEIPT AND PROCESSING OF BILATERAL AGREEMENT ANNEX SHEETS WITH PARTNERS.

The Invoice and Statement service handles the receipt and processing of invoice and statement information from partners. The service supports the capture of data from documents in many different formats including PDF and scanned images. It parses the data, checking for format and content errors and provides notification of acceptance or rejection based on rules tailored to the customer. The service includes a schedule of when documents are expected and will prompt the supplier accordingly. The approved data is stored in a central repository and uploaded into the inter-carrier billing and routing system.
